Style, Coverage and Restrictions

The photographer shall be granted artistic license with respect to all aspects of making photographs. The style and number of images made are at the discretion of the photographer though every effort will be made to satisfy the clients preferences. The photographer is not obliged to receive instruction from any third party and may not be held responsible for hindered performance due to uncontrollable external factors such as and including lighting, weather, non participation of guests or the restrictions imposed by certain venues or presiding authorities.

Products, Services and Supplements

The exact products and services agreed are outlined below. All products ordered and secured with a deposit will be supplied at current prices as per the date on this agreement. If the clients are responsible for these products being delivered any later than three months after the event the photographer may charge additional fees if suppliers or their prices have changed. Any additional purchases will be supplied at the prices advertised on the web site at the time of purchase. While there is great acceptance of relaxed timings the photographer is not obliged to work outside of the hours stated on this agreement even if important events are running later than scheduled. The photographer may be willing to provide extra time free of charge but the clients should not expect this. If on the day the clients wish to increase the contracted time by more than one hour they will be required to quickly sign an extension agreement and will be invoiced separately.

Finishing and Delivery

The photographer shall be granted artistic license with respect to the editing and finishing of all images in order to create the best possible visual output. The clients should be aware that images will appear different on different monitor screens and from different printer suppliers. The photographer will make every effort to manage consistent colours throughout but cannot necessarily compensate for undesirable lighting on the day. The clients will receive a final set of jpg's not raw images. The DVD slide show and disk of files if applicable will be delivered within two weeks and upon the clients approval of the layout design, delivery of the album will take a further four weeks.

Exclusivity

The photographer will be hired to provide sole paid photographic coverage of the Event. Friends and family are of course permitted to take pictures but they should not interfere with the photographer's duties.

Prices and Payment

The price for the chosen package is shown below. A non refundable deposit of 30% is required on the date of signing the agreement. Only once the deposit is received will the date(s) be reserved. The remaining non refundable balance will be due not less than thirty days before the event. Breach of these terms will be considered a cancellation and the photographer will be freed from this agreement. If Applicable, the clients must pay any additional fees required to permit photography at their chosen locations. It is recommended that this be checked prior to signing this agreement.

Limitation of Liability

Every reasonable effort will be made to provide a professional service and outstanding products. Any grievances or complaints must be made in writing within fourteen days of receipt of any products or services and the photographer's entire liability to the clients for any claim arising from the photographer's performance is limited to a refund of the amount the clients paid for the services. In the event of personal illness or injury the photographer will make every effort to arrange for a substitute photographer of equal technical ability to fulfil this agreement. This is not a guaranteed service as availability is often limited. The photographer cannot guarantee the skill or price of the substitute. If the clients decline this appointment they may terminate the agreement and will receive a full refund of all monies paid. In the event of the loss of original digital files by the photographer, the clients are limited to a full refund of all monies paid. No refund will be permitted for products already satisfactorily delivered.

Cancellation Fees

Cancellations earlier than three months prior to the event are settled by the retention of the deposit. Cancellations later than three months prior to the event will be subject to the full balance immediately payable.

Expenses

All Equipment, hire and delivery costs are included. Travel expenses for destinations within a 40 mile radius of North West London are covered. Destinations outside of this zone will incur additional costs and it may be necessary to provide overnight accommodation. The photographer need not have reserved seating during the reception but will require a meal during a short break.

Copyright and Usage

The copyright remains the property of the photographer. The photographer may use images for marketing, competitions and promotions at any time without specific consent. The clients are not authorised to use the images for their own or anyone else's financial gain or promotion. The clients may make use of any digital images supplied by the photographer for email, web or personal printing. The clients may not sell or make profit from reprints or digital images.

Agreement

The clients wish to employ the photographer and agree to be bound by these conditions. This agreement will be applicable to governing law and will not be amended without written consent from all parties. Client, date and location are non transferable.
